Frequently asked questions

Who is eligible for the Small Business Direct Install Program?

All small business customers with a GS1 or GS3 rate code on your bill are eligible for this program. This means that you have monthly peak demand of 200 kW or less. To confirm your eligibility, please call **1-866-432-5501**.

Who will perform the no-cost energy assessment and installations?

A trained Energy Technician will install any eligible products and perform your energy assessment while on-site. Each technician will have badges to identify themselves as representatives of our program.

How long does the process usually take?

Installation typically only takes between one and two hours, but may vary based on the size of the location and the number of products or type of equipment being upgraded. During this time, our goal is to minimize any disruption to your business, however, we do require full and safe access to the areas being improved.

We are committed to your safety, and your Energy Technician will coordinate with you on your individual safety protocols prior to your visit.

Can I keep my old bulbs and equipment?

No, inefficient products and equipment that are uninstalled will be removed from your facility by our Energy Technician.

What's included in my energy assessment report?

While your Energy Technician is on-site, they will look for new ways your business can save money through energy efficiency upgrades such as refrigeration, compressed air, integrated lighting controls and more. After any no-cost installations, you'll receive a complimentary, customized report by email that outlines your recommendations and approved contractors who can help provide lower cost estimates to save you energy and money.
